

Reopening Summary

- School plan to reopen TK-8 on November 2,
 2020 with Continued Distance Learning
- Administration is working with the County Department of Public Health to plan the reopening
- County will be doing site visit and reviewing data during the next few weeks

- Trying to bring the best of what we were able to do in distance learning this fall to the Virtual Academy




River Charters Distance Learning - TK - 3

- TK 3 Similar to current distance learning
 - 2.5 hours of synchronous learning
 - 90 minutes of asynchronous learning
- Synchronous learning will be with a live teacher
 - Teachers are highly trained and current staff that will be reassigned to this role
- Asynchronous learning will by using PathBlazer







River Charters Distance Learning - TK - 3

- 2 groups for synchronous learning
 - Grades TK -1
 - o Grades 2 3

River Charters Distance Learning - 4-8

- Grades 4 8 will remain with their current class and "zoom" in
- Students will work from home and follow the same schedule as their in classmates
 - Instruction Begins at 8:30 am each day
 - Instruction Ends at 2:30 pm
 - o Including art and music each week
- Teachers will prepare a packet of work in person or in google classroom for the "zoomers"



River Charter Schools Virtual Academy - Grades TK-8

- Fully Homeschool Distance Learning Program
- Students can participate fully virtually with no live instruction
- Students who have parent schedules that do not allow for school day live instruction or limited internet
- These students will be enrolled in PathBlazer or Edgenuity full time

Transition to Reopening


- October 13- 27
 - Synchronous Activities will continue
 - Teachers may make adjustments to asynchronous schedule
- October 26-30
 - Staff will be given 5 school days where there is no synchronous instruction to prepare and plan
 - Teachers/Admin will provide asynchronous activities for the students to remain engaged



- 5 days per week in school
- Student desks will be arranged for maximum distancing
- Masks will be worn at all times on campus
 - Students will be allowed to remove their mask when eating and playing outside and able to remain socially distanced
- At each transition, students will wash their hands
- Lunch will be outside (weather permitting)



- Students will remain in a cohort to ensure all students will be with the same group at all times
- Visitors and volunteers will not be allowed in classrooms
- Temperature and symptom checks will be done at the car or the gate of the school for walkers
- Extended period for pickup and drop-off




- Classrooms will be sanitized daily
 - Disinfecting foggers
 - Teachers and aides will help sanitize the classrooms throughout the day
 - Additional handwashing stations
- Hiring additional aides for each classroom to take students to recesses and lunch and provide additional support to the in person students and the "zoomers"

 We have been working with the county on the specifics of when to close down a cohort and when to close the school if cases increase -See Appendix 3



- If a student or staff member experiences
 COVID/flu like symptoms or has a fever at dropoff or during the school-day
 - Cohort remains open
 - Student sent home
 - Not return until 24 hours after symptoms ended



- A student or staff member <u>lives with or has</u>
 <u>been in close contact</u> with a person who has
 tested positive for COVID-19
 - Cohort remains open
 - Student should not attend school
 - Students will quarantine for 14 days
 - Letter will be sent to families



- A student or staff member tests positive for COVID-19
 - Cohort will close
 - All students and staff in that cohort will quarantine for 14 days
 - Letter will be sent to families
 - County will conduct contact tracing



- If a students is absent for a day or needs to quarantine, short term independent study will be available like in past years
 - Teachers will prepare packets or google classroom for the students to do their work



- If a cohort must be closed due to a quarantine
 - Teachers will use google classroom or Seesaw for learning
 - Students will return to the distance learning mode of the fall with their current teacher
- On the first day of a quarantine, there will be no synchronous instruction



 If 3 cohorts are forced to close on a campus due to COVID-19, then the entire school will be closed for 14 days to quarantine the school
